Report on Department Fleet/Mileage

The purpose of this report is to prompt an analysis of fleet management and mileage reimbursement within each Department and assist in the formulation of a report to the Governor on how to achieve greater efficiency and cost savings in this area. The report template includes sections for three projects for your convenience. This number is not a goal or target. You may add or delete boxes for as many projects as you submit.

ACTION PLAN FOR PROJECT 1:

- 1. Project Title: Realigning Current Fleet Assignments
 - 1.1. Brief description of project, goal, and action plan.
 - 1.1.1.The Department is evaluating the current assignment of fleet vehicles and commuter status, including review of the new divisions - the Assessment Coordination Division (ACD) and Arkansas Tobacco Control (ATC) - to identify areas of savings by shifting existing vehicles from areas of lower utilization to areas with high mileage reimbursement costs. Using guidance from the Internal Audit Division, data from the State Agency Vehicle Application (SAVA), and Arkansas Administrative Statewide Information System (AASIS), the Department is able to compare the cost of mileage reimbursement to the cost of vehicle ownership or vehicle rental. The Division of Revenue has performed a review of official station of employees previously assigned state vehicles and identified approximately fifty vehicles that will be available for reassignment. By reassigning existing vehicles, the Department will be able to better utilize its current fleet without having to purchase additional vehicles. Once the process is complete, the Department will assign an employee with the responsibility of ongoing review to monitor fleet utilization. As an example, ACD would be able to save an estimated \$100,000 in mileage reimbursement costs with the assignment of 20 existing Department vehicles. Prior to Transformation, the cost to ACD of purchasing that same number of vehicles would be estimated at over \$300,000. ACD does not have the budget or funding to procure the additional vehicles.
 - 1.2. Identify any additional resources required for the implementation and success of this plan.
 - 1.2.1. No additional resources are required other than staff time for the current and continued review of fleet utilization. This duty will be absorbed by existing staff.
 - 1.3. Are there any anticipated costs associated with the plan? Does your current budget have sufficient funds to cover all anticipated costs?
 - 1.3.1. The success of this plan will lead to cost savings; no additional budget or funds are required.

- 1.4. How will you measure the success and results of your plan? Include forecasts of cost savings, efficiencies achieved, etc.
 - 1.4.1. The success of this plan will be measured by comparing the year to year cost of mileage reimbursement and fleet ownership.
- 1.5. What is the implementation timeline and key action steps for this plan? How will you track progress?
 - 1.5.1. Time Line: Complete implementation by Spring 2020.
 - 1.5.2. Key Action Steps:
 - 1.5.2.1. Identify the total number of underutilized vehicles that are available for reallocation.
 - 1.5.2.2. Identify the employees/programs with high mileage reimbursement costs.
 - 1.5.2.3. Assign available vehicles to employees/programs with high mileage reimbursement costs.
 - 1.5.3. Track Progress: Progress will be tracked by using Fiscal Year 2019 expenditures for mileage reimbursements as a baseline for comparison. A full fiscal year of savings will be expected for Fiscal Year 2021.
- 1.6. Identify any obstacles to the implementation and success of this plan.
 - 1.6.1. The ability to reallocate vehicles will depend on the funding source that was used to purchase each vehicle. For example, if a vehicle was purchased with federal funds, it could not be reallocated to a state funded program without compensation to the federal program. This could limit the ability of certain vehicles being reallocated between divisions and programs. Funding itself could also be an obstacle.
- 1.7. How could Department of Transformation and Shared Services provide support to the Department?

 1.7.1. A statewide travel reimbursement system could help the Department with real time tracking of
 - travel reimbursement expenses. This would allow the Department to quickly identify any issues with adherence to the Department vehicle policy or if a program area is not efficiently utilizing fleet vehicles.

ACTION PLAN FOR PROJECT 2:

- 2. Project Title: Removal of unneeded vehicles from the Department's fleet
 - 2.1. Brief description of project, goal, and action plan.
 - 2.1.1. After completing Project 1, the Department will assess if there are any remaining underutilized or unneeded vehicles in the fleet. The Department will transfer or sell any identified vehicles through the Transformation and Shared Services Department. If sold, this will generate revenue for the statewide Motor Vehicle Acquisition Fund to replace vehicles at eligible departments and will save the Department annually in insurance and maintenance costs.
 - 2.2. Identify any additional resources required for the implementation and success of this plan.
 - 2.2.1. No additional resources are required.

- 2.3. Are there any anticipated costs associated with the plan? Does your current budget have sufficient funds to cover all anticipated costs?
 - 2.3.1. No additional costs are anticipated for this plan.
- 2.4. How will you measure the success and results of your plan? Include forecasts of cost savings, efficiencies achieved, etc.
 - 2.4.1. The success of this plan will be measured based on the funding generated to replace utilized vehicles while the Department still achieves efficiencies mentioned in Project 1.
- 2.5. What is the implementation timeline and key action steps for this plan? How will you track progress?
 - 2.5.1. Timeline: Complete by the end of Fiscal Year 2021
 - 2.5.2. Key Action Steps:
 - 2.5.2.1. Complete Project 1 Spring of 2020
 - 2.5.2.2. Identify the remaining underutilized vehicles
 - 2.5.2.3. Work with Divisions/Programs to ensure there are no upcoming changes in circumstance that will require the vehicles in the future.
 - 2.5.2.4. Transfer/sell remaining underutilized vehicles identified in Project 2.
 - 2.5.3. Track Progress:
 - 2.5.3.1. Progress will be tracked by comparing and monitoring fleet utilization and mileage reimbursements to prior fiscal year expenditures.
- 2.6. Identify any obstacles to the implementation and success of this plan.
 - 2.6.1.1. A potential obstacle could be changes in legislation requiring additional travel in any one Division/Program that could require more Department vehicles.
- 2.7. How could Department of Transformation and Shared Services provide support to the Department? 2.7.1.1. N/A

ACTION PLAN FOR PROJECT 3:

- 3. Project Title: Combining Fleets and Cross Training Agents for the Department's Regulatory Division
 - 3.1. Brief description of project, goal, and action plan.
 - 3.1.1.As a result of Act 910 of 2019, the Department has merged its regulatory functions Arkansas Beverage Control (ABC) and Arkansas Tobacco Control (ATC) under a single Administrator. As part of the transformation of this division, the Department is working to cross-train officers in both tobacco and alcohol control enforcement. The cross-trained enforcement officers will lead to a more efficient use of fleet vehicles and travel time. A cross-trained enforcement officer can conduct inspections and investigations for both substances, where, before Transformation, this would have required visits by two separate officers. Additionally, because of the officers covering both tobacco and alcohol, the territories assigned to each officer will be smaller than pre-transformation due to realignment of the coverage area for each officer. This will decrease the total time and distance the officers spend commuting from location to location.

- 3.2. Identify any additional resources required for the implementation and success of this plan.
 - 3.2.1. Currently the Department is working to identify any modifications or equipment that may be needed to allow the vehicles to be used for dual functions. One identified resource has been addressed by putting trackers in all officers' vehicles. ATC already had the trackers and they were added to all of the ABC vehicles. These trackers are a safety feature for the officers traveling all over the state but also provide the Department with valuable information on the use of the vehicle pertinent to fleet management.
- 3.3. Are there any anticipated costs associated with the plan? Does your current budget have sufficient funds to cover all anticipated costs?
 - 3.3.1. The Department continues to discuss possible adjustments to types of vehicles used and equipment, therefor the exact initial costs associated with the changes are still being determined. The Department has special revenue funding sources that can be used for any initial investment needed.
- 3.4. How will you measure the success and results of your plan? Include forecasts of cost savings, efficiencies achieved, etc.
 - 3.4.1. Success will be measured by comparing vehicle expenses in Fiscal Year 2021 to the baseline Fiscal Year 2019. At this time there is not a forecast of the exact cost savings because the cross-training of the officers is still underway and scheduled to be completed summer of Fiscal Year 2020. Once the cross-training is completed, the expectations and duties of the cross-trained officers will be finalized. The Department will then have the information needed to forecast cost savings.
- 3.5. What is the implementation timeline and key action steps for this plan? How will you track progress?
 - 3.5.1. Timeline: Currently Underway
 - 3.5.1.1. Review of the joint fleet between ABC and ATC
 - 3.5.1.2. Cross training of ABC and ATC officers
 - 3.5.2. Timeline: Summer 2020
 - 3.5.2.1. Cross training completed for the enforcement officers
 - 3.5.2.2. Territories assigned for the enforcement officers
 - 3.5.2.3. Adjustments made to vehicles assignments as needed based upon mileage and age of vehicle
 - 3.5.3. Timeline: Summer 2021
 - 3.5.3.1. Assess the cost savings by comparing Fiscal Year 2021 travel related expenditures to Fiscal Year 2019 and Fiscal Year 2020
- 3.6. Identify any obstacles to the implementation and success of this plan.
 - 3.6.1.An obstacle will be making sure the Department is able to isolate tobacco and alcohol related fleet costs from medical marijuana related fleet costs, so that the efficiencies are not skewed by the increased demand for travel due to the medical marijuana industry.
