- Approval of Minutes of October 18, 2023 Meeting* Motion to approve: Scott Foster Second: Scott Alsbrook Motion was unanimously approved
- Welcome and Opening Remarks, Mr. Matthew Charton
- Agency Report by Mr. Shelby Johnson, AR GIO
 - Presented the staff update, including status of the new Systems Specialist who will begin working with Matt DeLong after the first of the year. The search is still underway for a GIS Analyst.
 - Coordination activities since the last Board Meeting include APCO/NENA Conference in October; the Professional Surveyors Fall Conference in November; and the Open GIS Consortium in December.
 - The NG911 Project continues, with all counties now in the "Started" column. Notably, Pulaski County has moved into the "Load Pending" column.
 - NSGIC news includes Jonathan Duran serving as National Geospatial Collaborative President. He is currently attending the 2023 Innovation Days Meeting in Washington, DC. He will also attend the Mid-Year Meeting in Arlington, VA where he anticipates visiting with Arkansas' congressional staff.
 - Division of Land Surveys has exceeded last year and broke a new record in number of plats recorded and filed.
 - As of this date, 61 corners have been restored in-house and 119 by vendors. The budget was depleted within the first two months of the new fiscal year.
 - Governor Sanders held a "Capitol for a Day" event in Walnut Ridge. Because it was nearby, the Governor's Office was able to coordinate the participation of Gov. Sanders in a tribute to the three-county common corners of Greene, Randolf and Lawrence Counties. The governor assisted Steve Martin with placing markers on trees.

Old Business

- o Digital Orthoimagery Update
 - Referencing the Orthoimagery Project Map, blocks 1 through 6 have been delivered. Blocks 7 through 8 should arrive soon.
 - After the first of the year, the compiled imagery will be sent to counties and agencies rather than ask them to download their data.
- o LiDAR Project Update
 - On December 4, Sanborn notified the GIS Office they were cleared to fly, weather permitting.
 - The Western AR Project was awarded approximately two weeks ago and will be on the January Legislative Review for matching funding. This has created a scenario where AR will have Quality Level One data statewide. It may not be completed in this flying season, but it is on track. USGS has planned to initiate a coordination call, however that has not been scheduled. The Board will be updated as operations progress.
- Fulton County Tax Parcel Mapping Update
 - Fulton County has authorized rebidding their parcel mapping project, as current bids were well above budgeted amounts and limited in number.

- Publishing plat FOIA requests has consuming a great deal of time, with no significant return on the time invested. With 1.5 million site visits in 2023, only 1569 visitors accessed this page, or approximately 0.105%. The Land Survey Advisory Board approved this request at their last meeting.
- Division of Land Surveys would continue to respond to all FOIA requests, and the records will be maintained and available to all inquiries, but no longer published on the website.
