



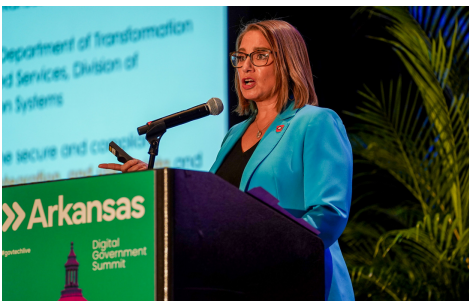

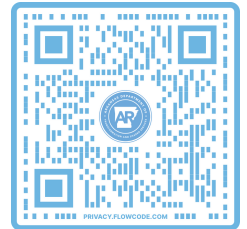
CUSTOMER SATISFACTION SURVEY
