Mobile application



Features:

Payment card



- With the ARBenefits/Optum Financial payment card there is no need to pay upfront and wait for reimbursement, as the card is accepted at most qualified care locations.
- Pay for qualified health care expenses; deducts from your Healthcare FSA or HSA
- Multi-purse functionality; HSA and FSA accounts are accessible with the same card



Payment requests

Pay Provider

Request payment directly to your provider

- Enter a payment request online or on the mobile app.
- Payment will be sent directly to the selected provider.

Reimburse Myself

Pay with personal funds and request reimbursement

- Pay for a qualified expense using personal funds
- Enter your claim online or using the mobile app
- Upload documentation online or with mobile app
- Receive reimbursement via check or direct deposit

Tip: Set up direct deposit for faster reimbursements!



Documentation overview

- Keep all documentation! For Health Care and Dependent Care FSA, the IRS requires all charges to be verified as an eligible expense.
 - While HSA expenses do not require all charges to be immediately verified, employees should still keep/upload all documentation on the off chance they experience an audit.
- Some expenses are verified automatically, all others require documentation that can be uploaded online, through the mobile app, and faxed or mailed to Optum Financial.
- Payment card may be suspended if documentation is not submitted
- Documentation must include 5 key pieces of information:
 - **1.** Who Name of the patient
 - 2. What Description of the service
 - **3. When** Date the service was provided
 - **4. Where** Name of the service provider
 - 5. **How Much** Amount/cost of the item or service

Tip: Your health plan Explanation of Benefits (EOB) typically contains all the required information!
