As grounds, RazorClean Building Services Inc. firmly believes that the awards given to other contractors on this state building and others RazorClean Building Services Inc. had contracts on had more complaints against them than RazorClean Building Services Inc. Therefore, the designation of RazorClean Building Services Inc. as “Non-Responsible” is unwarranted based on those facts. Additionally, RazorClean Building Services Inc. contends that by doing so, the individuals responsible for awarding bids failed to adhere to the rules of procurement in good faith when RazorClean Building Services Inc. was designated as “Non-Responsible” yet others, as mentioned, were not. This is a very harmful designation to attach to a company. By designating as “Non-Responsible”, RazorClean Building Services Inc. has been denied the equal protection of the laws and procedural due process by others not receiving this designation yet having more complaints than RazorClean Building Services Inc does and that any complaints, which we do not concede were originated in good faith, were sufficient to cause the designation “Non-Responsible. We feel that all three of the subsections cited have been violated by this designation of “Non-Responsible” when the facts simply do not support such a designation.
